Whenever The Term "The Local Union" Is Used In This Contract, It Shall Mean The Local Union Of the Federation With Jurisdiction Over the Territory In Which The Engagement Covered Is To Be Performed.

THIS CONTRACT for the personal services of the musician(s) on the engagement described below is made this _____ day of _____ between the undersigned purchaser of musician (herein called "purchaser") and the undersigned musician or musicians.

GENERAL PROVISIONS

6. No performance or rehearsal shall be recorded, reproduced or transmitted from the place of performance, in any manner or by any means whatsoever, in absence of a specific written agreement with or approved in writing by the American Federation of Musicians ("Federation") relating to and permitting such recording, reproduction or transmission. This prohibition shall not be subjected to procedure of arbitration and the American Federation of Musicians ("Federation") may enforce this prohibition in any court of competent jurisdiction.

7. It is expressly understood by the Purchaser and the musician(s) who are parties to this contract that neither the Federation nor the Local Union are parties to this contract in any capacity except as expressly provided in 6 above and , therefore, that neither the Federation nor the Local Union shall be liable for the performance or breach of any provision hereof.

8. A representative of the Local Union, or the Federation, shall have access to the place of engagement covered by this contract for purposes of communicating with the musician(s) performing the engagement and the Purchaser.

9. The agreement of the musicians to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control.
